

Tenure-Track/Tenured Faculty Position in Cancer Epidemiology:

The Department of Epidemiology and Biostatistics at Case Western Reserve University (CWRU) School of Medicine (<http://epbiwww.case.edu/>) and the Case Comprehensive Cancer Center (CC Cancer Center: <http://cancer.case.edu/>) invites candidates to apply for a tenure-track/tenured faculty position in Cancer Epidemiology. Faculty rank will be determined through CWRU's multi-level review process focusing on such past achievements as the candidate's publication record, degree of national level activity and recognition, and funding history. Applicants must have a PhD and/or MD, a strong record of peer-reviewed publications, and external research funding (corresponding to current faculty level). We are interested in researchers focused on the molecular and genetic epidemiology of cancer, but will consider strong applicants in other research areas. Preference will be given to applicants using (big) data integrated across different sources. Applicants will also have a strong interest in participating in our active and growing graduate MS and Ph.D. programs (~135 students) in health informatics, bioinformatics, biostatistics, population & quantitative health sciences, and public health.

The primary appointment will be within EPBI, with an associated appointment in the Cancer Prevention, Control & Population Research (CPCPR) program at the CC Cancer Center. CWRU has multiple Cleveland-wide cross-institutional initiatives including the CC Cancer Center and the Institute for Computational Biology (ICB: <http://www.icompbio.net>). The mandate of the ICB is to enable the sharing of biomedical big data across Cleveland's multiple health institutions (University Hospitals, Cleveland Clinic, MetroHealth system) to foster scientific discovery. The CC Cancer Center captures the vast majority of cancer care in northeast Ohio and along with the ICB provides a rich resource for cancer researchers.

Collaborative research and team science are critical components of this position. A competitive recruitment package and excellent benefits will be provided. In addition, the successful candidate will:

- enjoy working in a collaborative academic health care setting
- collaborate within and across disciplines and sectors
- teach and advise graduate students with a commitment to excellence
